I. Approval of minutes of previous meeting - Kathy motioned to approve the May 2024 monthly meeting meeting and Craig the motion. All in favor.

III. Agency and Land Manager updates and discussion as needed (30min)

- a. SLO County
 - i. El Chorro Regional Park - James reported by email that he will be on a call with American Ramp Company this week on Friday to review their design for the front of the bike park area. He also met with the County facilities manager, Hugo Bastidos about using county land for NICA cross country racing events. NICA organizers will need to be contacted for their input. Craig is doing mapping.
- b. LPNF and Cal Poly/West Cuesta Trails - In monthly meeting, Craig reported that LPNF is proceeding on West Cuesta trail project. Asbestos contamination roadblock they can get by. There is a proposal for closure of TV Tower for public motor vehicle use. [Craig will look into the property management of the Poly Canyon for the range land area.](#)
- c. City of SLO - Niels sent out email that they hired a new ranger. They are regrading the main fire road on Cerro San Luis and going to do other trail changes. Also, they are making repairs to Quercus Connector.
- d. State Parks - Supervisor Alex Johnson is taking over Blake Thorin's Chief Maintenance Officer position. Jim is working with Alex on updating trail signs. Adjacent to Montana de Oro on the Diablo Canyon land, trails are still being considered though decisions will be entirely at the discretion of the YYT Chumash tribe.
- e. LCSLO - Freedom Tracks wants to do modifications to Spring to Spring at Pismo Preserve to level out the trail and make it manageable for offroad track mounted wheelchair access. Maintenance and modifications will be done by the Thursday crew. Christie is doing Ride Sesh clinic with Danilu monthly, first Tuesday of the month at Pismo Preserve. \$20 donation to CCCMB.
